

## Summary

### **Petrétei, Dávid: Crime Scene in the light of standardization trends and the new criminal procedure law (4-48)**

This paper deals with some of the current issues of crime scene investigations by the Hungarian investigating authorities. The new Criminal Procedure and Administrative Procedural Laws and the related legislation; the quality assurance and standardization processes within the framework of EFSA 2020; the continuous scientific and technical development; and the issues of other legal areas that are recently linked to criminal law are being discussed. The study received a first prize in 2017 at the Police Science Council's application.

### **Rácz, Attila: The migration crisis here and beyond. Compassion, rejection and solidarity (49-70)**

This study is analysing how the attitudes changed in these smaller territorial units or societies which was affected by the migratory crisis directly. Aim of this analysis is to show those possible explanations and interpretations which are lying behind the quantitative data. This study try to show the attitudes to migration among the civilian population and the changes in their subjective sense of security, based on empirical data, along the Southern border in Hungary.

### **Birkner, Zoltán – Marton, Zsuzsanna – Keller, Krisztina: Innovation in Tourism Safety and Security – Focus on Education and Academic Research (71-80)**

Global tourism safety and security has got even more attention from the market and state players due to the terror attacks in the past decade. The importance of the phenomenon is proven by the fact that the more and more academic studies have focused on the analysis of the linking points between
